



# Safety Rewards Certification Form

The Avemco Safety Rewards Program is a two-part annual premium credit program comprised of ground and flight training. This program is an innovative approach to rewarding pilots for participating in additional training. By completing any FAA Team WINGS Knowledge Course worth one (1) full WINGS credit or more (which include many of the WINGS online courses, King Schools Practical Risk Management courses\*, FAA-sponsored seminars, and other qualifying courses) AND taking Avemco-recognized flight training, you can earn a 10% annual premium credit. AND NOW, you also can qualify for the full 10% premium credit if you obtain a new certificate or rating!

Upon your notification to us of successful completion, the Avemco Safety Rewards Credit(s) will be applied immediately to your policy for the current policy period. The maximum credit that can be applied to any one policy period is 10%. Please note that the ground and flight training parts may be completed in any order. However, the training program must either be completed during the policy period or within the 12 months prior to the start or renewal of your policy.

## 1 FAA Team WINGS Knowledge Courses Worth One (1) Full Credit or More

To qualify for a 5% ground training annual premium credit, all named pilots must successfully complete their own course worth one (1) full FAA WINGS credit or more. Please note that the 5% credit can only be given once per completed WINGS Knowledge course.

## 2 Avemco-recognized Flight Training

To qualify for a 5% flight training annual premium credit, all named pilots must successfully complete Avemco-recognized flight training. The following guidelines apply to Avemco-recognized flight training:

- At least 2 hours of flight training beyond the FAA mandated minimum requirements
- Relevant to the type of aircraft insured
- Relevant to typical flight operations conducted in the insured aircraft
- Enrollment in or completion of a manufacturer-approved FAA Part 141 flight training program

Yes! All named pilots have completed qualified flight training. Please include documentation for each pilot.

ENCLOSED is a copy of:

- Logbook Endorsement for the training
- Certificate of Completion
- FAA Part 141 Certificate of Enrollment or Graduation

## OR Obtain a New Certificate or Rating

To qualify for the full 10% annual premium credit, complete a new certificate or rating during the approved timeframe (noted above).

Enclosed is a copy of the new Pilot Certificate (A temporary certificate is acceptable).
